The Protection Profile identified in this report was assessed according to the procedures on Assurance Continuity [1] and the Impact Analysis Report (IAR). As the changes to the protection profile and the corresponding impact have been sufficiently discussed the protection profile version 1.6.2 [4] with change marks to the previous protection profile version 1.6.1 [3] functions as the IAR. The baseline for this assessment was the Certification Report, the Protection Profile version 1.5.9 and the Evaluation Technical Report of the Protection Profile certified by the Federal Office for Information Security (BSI) under BSI-CC-PP-0098-V3-2021 [2].



The change to the certified Protection Profile is at the level of an application note. The changes are introduced to include the operation SecureSendAPDU to support the the PoPP-Service according to "Spezifikation Konnektor" version 5.24.0 [5]. The change has no effect on assurance. The identification of the maintained Protection Profile is indicated by a new version number compared to the certified Protection Profile.

## Assessment

The Protection Profile identified in this report was assessed according to the procedures on Assurance Continuity [1] and the Impact Analysis Report (IAR) (the new protection profile of version 1.6.2 [4] with change marks). The baseline for this assessment was the Certification Report of the certified Protection Profile and the Evaluation Technical Report as outlined in [2].

The author of the Common Criteria Protection Profile *Common Criteria Schutzprofil (Protection Profile) Schutzprofil 2: Anforderungen an den Konnektor, Version 1.6.2*, BSI submitted the protection profile of version 1.6.2 [4] with change marks to the previous PP version 1.6.1 [3] to the certification body of the BSI for approval. This document is intended to satisfy the requirements according to the procedures on Assurance Continuity [1]. In accordance with those requirements, this document describes the changes made to the certified Protection Profile.

The Protection Profile *Common Criteria Schutzprofil (Protection Profile) Schutzprofil 2: Anforderungen an den Konnektor, Version 1.6.2* was changed due to the introduction of the operation SecureSendAPDU to enable the PoPP-Service according to "Spezifikation Konnektor" version 5.24.0 [5].

## Conclusion

The change to the Protection Profile is at the level of an application note. The change has no effect on assurance.

Consideration of the nature of the change leads to the conclusion that it is classified as a minor change and that certificate maintenance is the correct path to continuity of assurance.

Therefore, BSI agrees that the assurance as outlined in the Certification Report [2] is maintained for this version of the Protection Profile [4].
